#### Description

#### Pilot project for biodiversity islands on private properties

The objective for the biodiversity island pilot project is to allow vegetation to grow beyond 30 cm in order to favour the establishment of indigenous plants, thus helping promote biodiversity, such as the presence of pollinating insects. In addition to the benefits for diversity, a taller lawn will require less water and fertilizer and offer better resistance to pest insects!

For the first year of the pilot project, only 30 residences will be selected. Participation in the pilot project for biodiversity islands will be valid for one year only.

The application submission period to participate in the pilot project will run between May 10 and June 1<sup>st</sup>. The Environment Section will contact applicants during the first week of June to confirm their participation in the pilot project. Each participating residence will receive a sign to be installed on the grounds to identify the biodiversity island, along with a bag of wildflower seeds.

During the summer, a staff member from the Environment Section will visit the participating residences to assess the biodiversity islands and make sure they comply with the required criteria.

Biodiversity islands on private properties are authorized to be set up in front yards, side yards or backyards. They must however meet the following criteria and conditions:

#### 1. Criteria

- Must be located in one of the following areas:
  - o Des Chenaux
  - o Vaudreuil City Centre
  - o Des Floralies
- Keep a clear strip of land measuring 2 metres along public roadways, bicycle paths, and private entrances.
- Keep a clear strip of land measuring 2 metres around all buildings.
- Keep a clear strip of land measuring 2 metres along property lines.
- Keep a clear strip of land measuring 3 metres around any combustion appliance (outdoor conventional or fuel-operated fireplace, outdoor cooking appliance running on charcoal, propane or gas).
- Biodiversity islands must not obstruct road signs or the building's civic number.
- For corner lots, the vegetation located within the visibility triangle must be less than 0.9 metres tall.

### **Conditions**

Plants that are harmful to health or pose a risk to the environment must be controlled to limit their spread. They should be disposed of in the garbage in a sturdy bag to prevent spread.
